

The following are suggestions from the Coalition for Jewish Values for incorporation into the platforms of America's political parties, during and beyond the 2024 election cycle, to address Antisemitism domestically, internationally, and in foreign affairs. We look forward to noting with gratitude the incorporation of these suggestions into the platforms of all political parties in the current election.

Addressing Hate in America

- 1. The United States should recognize the International Holocaust Remembrance Alliance working definition of Antisemitism, with its contemporary examples, government wide, to the exclusion of any other definition (including that of section 3 of the Never Again Education Act, which lacks the contemporary examples).
- 2. Due to rising Antisemitism in the United States, there should be, within the Executive Office of the President, a National Coordinator to Counter Antisemitism, with no other duties or roles, to coordinate domestic efforts to respond to Antisemitism. This should not impact the role of the Special Envoy to Monitor and Combat Antisemitism within the Department of State.
- 3. Terror-supporting organizations must not be able to operate, tax exempt, in the United States. Criminal charges must be brought against the leaders of such organizations and they should be stripped of tax exempt status.
- 4. The United States cannot provide a tax exemption, much less funding, to any institution of higher education or any other organization or company that provides recognition, funding, space or services to a student or other organization which, either individually or through its national headquarters, is a terror-supporting organization.

 Demonstrating, publishing slogans and other propaganda, and declarations of support for a terror organization must be considered to be providing material support or resources.
- 5. The United States must reject any effort to boycott Israel, companies doing business with Israel, trade with Israel, academic and other exchanges with Israel and Israeli citizens, as antisemitic and counterproductive to any effort towards peace.
- 6. No federal funding can be provided to any institution of higher education accepting foreign money to fund, in whole or significant part, any campus department, program, or academic chair.
- 7. The United States should not provide visas for foreigners arriving from countries, including the Palestinian Authority and Gaza, where

- the majority of the population, according to the ADL surveys, are indoctrinated to believe anti-Jewish tropes.
- 8. University administrators are overriding law enforcement, denying local law enforcement access and telling campus police not to interfere. No College or University shall receive federal funding if the administration or campus police prevent open access to local law enforcement responding to complaints of hate crimes, discrimination, or violence, at the sole judgment of local law enforcement.
- 9. The Department of Justice must step in and immediately level criminal charges when local law enforcement refuse to do their job, as when Columbia students were arrested for trespassing for hateful purposes and Alvin Bragg claimed "lack of evidence" against students arrested while trespassing.
- 10. The DOJ must enforce Federal hate crime, RICO, and other charges against any form of campus agitation, violent misdemeanor or felony perpetrated when demonstrating against or otherwise targeting Israel or Jewish targets.

Addressing Hate in the Middle East and Internationally

- 1. The Abraham Accords must be encouraged and expanded, to increase peace in the Middle East.
- 2. The United States must provide to Israel all arms necessary for Israel's defense, without any delay or pause.
- 3. The United States must back Israel's decision making regarding any attack against it or its residents, and any effort to secure its territory for the life of its citizens, residents, and visitors. The United States must attribute all deaths, injuries, and damage incurred during Israel's actions to defend and secure the security of its territory to the terrorist organizations and enemy nations that forced Israel to take such actions.
- 4. The United States must regard the Children of Israel, Jews, as the sole indigenous population of the Land of Israel, including Judea, Samaria, and Gaza, and affirm that Jerusalem is both the historic and current capital city of Israel.
- 5. The United States must reject the classification of territories liberated by Israel as "occupied." This applies especially to the site of the Cave of the Patriarchs in Hebron, the site of the Holy Temple in Jerusalem, and other Holy Sites identified in the Hebrew Bible.
- 6. The United States must reaffirm its recognition of the annexation of Jerusalem, the Golan Heights, and other territories gained by Israel in its defensive wars, and respect Israel's determination regarding the

- legality of Israeli towns and villages ("settlements") in all territories held by Israel.
- 7. The United States must encourage all states to move their Israel embassies to Jerusalem, the Capital of Israel.
- 8. The United States must defund the Palestinian Authority and any other body that provides funding or cash rewards to those committing acts of terrorism.
- 9. The United States must withdraw from the Joint Comprehensive Plan of Action with Iran and impose sanctions upon any nation providing funding for terrorism.
- 10. The United States must reject as untenable any "Two State Solution" that would involve a country governed by parties that, at any point in the decade prior, provided funding for acts of terrorism or cash rewards to those committing acts of terrorism. The United States must denounce as bigoted and hateful any effort to describe any other party as an impediment to peace while such funding and support continue.
- 11. The United States must reject any effort to create or recognize any new state in territories held by Israel until the above conditions are met, and/or not achieved solely through direct negotiations between Israel and a party that has, without condition or exception, rejected any criminal attack upon any Israeli citizen, resident, or visitor.
- 12. The United States must reject as racist the classification of any Arab, but not Jew, whose family ever lived in British Mandatory Palestine west of the Jordan river, as a "Palestinian." Such language revises Jews out of two thousand years of history in that region, and gives voice to the false claim that Arabs, rather than Jews, are indigenous to the Jewish homeland. The term "Palestinian" is only legitimate as a moniker for citizens and officers of the Palestinian Authority. Arab citizens of Israel and residents of Gaza cannot be described in any United States government document as "Palestinians." They should be described accurately as "Israeli Arabs" and "Gazan Arabs."

Addressing Hate at the United Nations, International Criminal Court, International Court of Justice and other International Bodies

1. The United States must impose visa- and property-blocking sanctions against those foreign persons (individuals or entities) that, as ICC employees or associates, against members of the U.S. Armed Forces, employees and contractors of the U.S. government who assist the U.S.

- Armed Forces, and certain members of the governments and armed forces of U.S. allies or partners.
- 2. The United States must impose sanctions against any nation whose government files charges against any of these at the ICC, or charges against U.S. allies or partners at the ICJ. Additionally sanctions must be imposed against any nation nominating a judge to either the ICC or ICJ who votes to authorize or convict any such charges.
- 3. It is unconscionable that the international community is not treating refugees in any Arab-Israel conflict similarly to those of all conflicts, and working to resettle them and decrease their number. The United States shall permanently withdraw from and defund the United Nations Relief Works Agency or any successor or other organization focusing solely upon Palestine Refugees.
- 4. Other countries have abused the United Nations Human Rights Council, the United Nations Economic and Social Council, and similar bodies to demonize Israel while avoiding serious human rights crises. The United States shall permanently withdraw from and defund any UN or international agency or group which regularly refers to "Israeli occupation" or has a consistent agenda item designed to denigrate the State of Israel and its citizens.
- 5. Other countries have abused the United Nations Security Council to demonize Israel while avoiding serious human rights crises. The United States shall, for the next four years, veto any and all UN Security Council resolution criticizing Israel or attempting to impose limitations upon decisions made by Israel regarding its defense and security.
